

As per proceedings held on 22.06.2023, the Inspection of the Listed Documents has been scheduled at 11AM today, i.e 26.06.2023, in the chamber of IO.

2. The PO is present alongwith the listed documents in original as per Annexure III of the Charge Memorandum dated 27.06.2022. The CO is absent. No communication whatsoever, has been received from the CO till the time of recording of this Daily Order Sheet.
3. The CO has therefore, failed to avail of the opportunity extended to him to inspect the listed documents in original and raise dispute if any, with regard to authenticity of any listed document.
4. The 13 (thirteen) documents as listed at Annexure III of the Charge Memorandum dated 27.06.2022, are taken on records of the Inquiry, and marked as State Exhibits S-1 to S-13.
5. Now, the following are ordered: -
 - a. The CO is directed to furnish the list of documents which he considers as needed for his defence, duly indicating the relevance of each such document and the name of the custodian of each document. The list shall be provided to the IO latest by 11:00 hrs of 28.06.2023.

- b. The CO is further directed to furnish the particulars of his Defence Assistant, if any, latest by 11:00 hrs of 28.06.2023.
- c. The examination of State Witnesses shall be conducted on 28.06.2023, from 15:00 hrs onwards at PPEG Conference hall, Admn building, SDSC SHAR. The PO is directed to conduct the examination in chief. The CO is directed to attend the hearing and avail of the opportunity of cross examination of state witnesses.
- d. If the CO fails to respond and/or, attend the hearing as scheduled, the proceedings will be conducted and concluded ex-parte. No further opportunity will be extended to the CO with respect to examination / cross- examination of any 'State Witness'.
